## Initial Fee Schedule NOTES

- If you are submitting your application electronically please complete and print off the fee schedule and submit your fee cheque by mail.
- Please note that we are unable to process your application without payment of fees.

**INITIAL application:** Fees are based upon your operations gross sales of organic (or non-organic products/produce as in the case with some initial applications) and from your whole operation from the previous year. Gross sales of organic products would include all organic sales regardless of whether they are sold on the organic market or conventional market.

- **As per COABC Annex 2 version 9, Inspectors will confirm the operations gross organic sales. (This remains confidential)**
- **INSPECTION COSTS:** The cost of the Initial Inspection will be billed once the inspection is completed and it is to be paid upon receipt.
- **Certification Committee Reviews:** The cost of evaluating one application by FVOPA's Certification Committee is included.

### **ADDITIONAL FEES will apply for the following:**

- If submitting two or three types of applications under one operation, there is an extra CC review fee for each additional type/ operation ( Eg : Farm Crop & Processing , Farm Crop & Livestock, and different locations that require separate reviews). The cost of the extra CC review/s is the same cost as the CC review listed in the operations declared Fee level.
- **Second Inspections:** If an operation requires a second inspection, the operation will be billed the second inspection costs, CC review and admin charges, to be paid upon receipt.
- **Input reviews:** \$150 will be charged for the CC to review and research inputs submitted for approval.
- **Label reviews:** \$150 will be charged for CC to review new or revised labels submitted for approval after Inspection.
- **New product reviews:** \$150 will be charged for CC to review new product profiles and the accompanying documentation submitted for approval after Inspection.
- **Additional CC or Admin fee:** \$50 per hour may be charged for complex certification issues that require extraordinary time and/or research to resolve by either the certification committee or administration or if there is a need to review additional information that was incorrect or missing off the application form – such as product profiles, labels, input certificates etc.
